- Players and coaches will be allowed to enter the playing site with their Showcase Bag Tag provided at Check-In. Please be sure to have the players secure their tag to their backpacks and coaches wearing their COACH wristbands on their wrist. The Woodside Group (management for the Wisconsin Dells Center) handles and collects all admissions.
- Coaches listed on multiple rosters will only receive ONE wristband for the event.
- Teams will have a minimum of 1 match on Sunday.

ATTENDANCE WAIVER

All persons attending this event are bound by and accept the following:

1. NetLynx Sports are private events. Absolutely NO outside commercial photographers or professional videography is permitted at any time.
2. No artificial noise makers are permitted at NetLynx Sports Events. This includes the use of "boom boxes" or speakers projecting music during team warm-ups or competitions.
3. The sharing of any admittance credentials or wristbands is prohibited and will result in the confiscation of those credentials and expulsion of the persons involved for the remainder of the event.
4. Warning: Risk of injury from flying objects incidental to the sport of volleyball may occur at this event. Attend at your own risk. Please pay close attention to your surroundings and be always on alert, especially during active play.

Release of Liability, Assumption of Risk, and Consent for Use of Likeness

In consideration of being admitted to any NetLynx Sports events (or simply, "Event") and allowed to participate in any way in the Event, related events, and activities, I acknowledge and agree that:

1. The risk of injury from the activities involved in this event is significant; and,

ADMISSIONS AND PARKING

Woodside Wisconsin Dells Center and JustAGame (JAG):

Tickets purchased online will receive a QR code that must be presented upon entrance at the Wisconsin Dells Center or JustAGame in order to receive your wristband following scanning.

Three day and single day passes will be available on site for cash or credit:

- **Three-day pass = \$35** (tax and facility fees included)
- **Single day pass = \$15** (tax and facility fees included)
- Parking Fee at Woodside Wisconsin Dells Center Only is **\$5 per day CASH ONLY.**

Please be advised that the number of people allowed into the facilities could change prior to the event and that this may require us to change the ticketing policy to limit attendance. This would be out of our control and would be based on governmental regulations.

Please note:

- All sales are final. All sales are **NON-REFUNDABLE & NON-TRANSFERABLE**.
- Single day passes will have a unique hand stamp each day that is visible under a black light that will allow them entry at all playing sites for the day.
- Purchased Wristbands must be displayed each time you enter the venue and will grant you entry to all playing sites for the entire event.
- **Wristbands must be worn on the wrist.** Wristbands on purses or backpacks will not be recognized.
- Lost, forgotten, or stolen wristbands must be re-purchased. We do not replace weekend passes because you cut the wristband off.
- Children 5 and under are free. They do not require a wristband.
- Parking Fee at Woodside Wisconsin Dells Center ONLY is \$5 per day. Coaches/Directors are not exempt from this fee. At the time of this packet creation, there are no parking fees in the downtown Dells during this time of year (JAG).

Players will receive special participant bag tags when their coach checks in on Thursday. Coaches will receive special COACHES ONLY wristbands when checked in on Thursday.

HOUSING INFORMATION
